

Preliminary exploration of system construction for "Internet Plus Youth Affairs Social Work"

"Internet Plus" is about deeply integrating the innovative achievements of the internet with various fields of the economy and society, promoting technological progress, improving efficiency, and fostering organizational change, thereby enhancing the innovation and productivity of the real economy and forming a new form of economic and social development that takes the internet as infrastructure and an element of innovation. In the era of "Internet Plus," the internet has transcended an industrial category, infiltrating like the wind in the night, silently nourishing all things, and cultivating many emerging industries and business forms, which will become the innovation and efficiency engine for national economic and social development.

So-called youth affairs social work refers to a service activity and service process guided by professional values, using professional theories, methods, and skills based on the physical and mental characteristics,

motives, needs, and interests of young people to help them solve problems, overcome difficulties, restore functions, and achieve comprehensive development. At the same time, they can mobilize all kinds of resources in the environment and improve the environment to promote a positive interaction between young people and the social environment. At that time, the youth affairs social work of "Internet Plus" will form a unified pattern nationwide. Through the networking of services and the networking of work, information sharing, resource sharing, and achievement sharing of youth services will be realized, social resources will be integrated and fully utilized, and corresponding services will be provided for the youth group, thus promoting young people to become useful and pillar talents for society.

On the other hand, experts and scholars in the fields of computer science and new media, as well as front-line social workers, can be expanded into the part-time and full-time teaching staff, offering courses such as "Big Data Analysis" and "New Media Application" that incorporate "Internet Plus," in order to enhance the knowledge reserve and skills of youth affairs social workers.
